

# Oneida Casino RV Parking Rules & Customer Information

Oneida Casino RV parking rules and customer information are provided to help make your stay with us fun, enjoyable, and without incident.

**RV PARK OPEN: May 1 through Labor Day (First Monday in September)**

1. Guests must be 21 years of age or older to register for a RV parking site.
2. Guests must be a Player's Club member to register for a RV parking site.
3. RV Permits will be issued at the IMAC Casino Players Club.
4. The cost of each RV parking site may vary. Refer to the Players Club for specific payment forms and details.
5. RV owner is responsible to maintain current vehicle registration and insurance. Must show proof of both upon request.
6. **Checkout time is 12:00 PM.** RV Parking site must be clean before departing. RVs not checked out by 12:00PM. are subject to being towed at owner's expense.
7. Vehicles must be parked in assigned stalls only (between the marked lines). Parking on grass, gravel, or in the street is prohibited.
8. All RVs and manufacture-approved conversion vans must have sleeping facilities, window coverings, and approved electrical hookups.
9. All RVs must be capable of being moved immediately upon notice. If an owner cannot move a vehicle, they must have it moved by a third party, at the owner's expense.
10. RV or vehicle mechanical work, of any kind, is prohibited on Oneida Casino property.
11. Staking sharp objects in the asphalt is prohibited. Guests are encouraged to place platforms under any protruding equipment (i.e. jack stands) that may contact and damage the asphalt during hot days.
12. Cab-over campers may not be removed from the vehicle and placed on the ground.
13. Tent camping, sleeping in cars or sleeping outside of the RV is prohibited.
14. Storage is prohibited under or around any vehicle. Structures external to the RV, and which are not an integral part of the RV, are prohibited. This includes, but is not limited to: storage sheds, gazebos/screen rooms, storage totes, work benches, fences, plants, ornamental objects, and gas cans.
15. Additional motor vehicles may park in the designated parking area (located on the Southwest corner of the IMAC Casino parking lot) if available, free of charge. Electrical outlets are not available in that area.
16. "Quiet time" is between 10:00PM and 7:00AM. Voice, radio and television volumes should be reduced. Other disturbing noise and activity is to be controlled, and appropriate, during quiet time. Operating generators is prohibited.
17. Trash is to be placed in waste containers located throughout the RV Parking site. Waste containers cannot accommodate large items. Do not dispose of hazardous waste items. Any hazardous waste that spills from an RV which results in contacting a third party for cleanup will be done at the RV owner's expense.
18. Wastewater and sewer waste must never be discharged onto the ground.
19. Open fires and fireworks of any kind are not permitted at any time. Charcoal or gas grills are acceptable.
20. Hanging clotheslines and/or clothes outside of the RV is prohibited.
21. Pets are permitted and must always be on a leash. All pet waste shall be collected and disposed of properly.
22. Posted speed limits and traffic signs must be adhered to.
23. Guests are responsible for the conduct, behavior, and control of your children and visiting guests.
24. Guests are financially responsible for any damage to Oneida Casino property, intentional or accidental.
25. Willful damage or defacing of Oneida Casino property may result in immediate eviction and/or possible prosecution.
26. Reservations may be made for a maximum of 10 consecutive days. New reservations may be made after being off-site for 10 days.
27. Oneida Casino reserves the right to deny the parking of any vehicle by guests whose vehicle is deemed unsafe, excessively noisy, or visually distracting.
28. Oneida Casino is not responsible for loss or damage due to fire, accident, vandalism, theft, or acts of nature.
29. All guests and vendors are responsible for abiding by Oneida Casino rules and policies. Any person failing to adhere to the Oneida Casino RV Parking rules and policies may be evicted from the RV parking site at the sole discretion of the Security Director or designee.
30. Cancellations can be done directly from the confirmation email that was received when the reservation was made.
